Re: Systemwide Review of Proposed Presidential Policy "Travel Regulations"

Dear Colleagues:

Attached for Systemwide Review is a revision to Presidential Policy, Travel Regulations. The current version of the policy is posted here: <u>https://policy.ucop.edu/doc/3420365/BFB-G-28.</u>

The main changes in this revision are:

1). Incorporation of the Internal Audit recommendations regarding documentation necessary to support first or business class travel, and the need to document the business purpose of each day of the trip;

- 2). Update the policy for the new IRS business mileage reimbursement rate effective January 1, 2020;
- 3). Substitute gender-neutral language throughout the policy:
- 4) Add a new section on sustainable travel; and

5). Clarified what is included in the foreign per diem and link to the Department of State website in Appendix B.

All of the comments received were reviewed and where possible, incorporated into the policy that is submitted for systemwide review.

Systemwide Review

Systemwide review is a public review distributed to the Chancellors, the Director, Lawrence Berkeley National Laboratory, the Chair of the Academic Council, and the Vice President of Agriculture and Natural Resources requesting that they inform the general University community, affected employees, and union membership about policy proposals. Systemwide Review also includes a mandatory, 90-day full Senate review.

Employees should be afforded the opportunity to review and comment on the draft policy. Attached is a Model Communication which may be used to inform non-exclusively represented employees about this proposal. The Labor Relations Office at the Office of the President is responsible for informing the bargaining units representing union membership about policy proposals.
